

# Interchange Agreement

## FIDA & (insert league name)

An Agreement between the **Football Integration Development Association (FIDA)** and **insert league name** that is on-going until it is revoked by one of the football bodies involved.

**FIDA and (insert league name)** agree that registered players of a league may interchange between **FIDA and (insert league name)** OR (between both Leagues), subject to meeting the following conditions.

### Conditions of Interchange Agreement:

- 1) The player(s) and clubs party to the interchange agreement concerned **must** abide by the conditions of this agreement as outlined below.
- 2) Due to eligibility requirements, players **must be fully registered with a FIDA club** and may only be permitted outwards to external clubs and leagues
- 3) All participating players must be properly registered in PlayHQ prior to participation
- 4) Players must be eligible under the by-laws and competition regulations of both leagues
- 5) Players must hold a valid permit for each match
- 6) Breaches will be penalized under the host leagues by-laws
- 7) The agreement is subject to AFL National Policies, AFL Victoria Rules and each League's By-Laws, where inconsistencies arise, the host league's rules apply on match day
- 8) All players, official and spectators must comply with the host leagues Code of Conduct, the originating club remains jointly responsible for behaviour breaches
- 9) Should both leagues agree that the Interchange Agreement can be used during their final's series, a player playing under such Interchange Agreement **must** have met all finals eligibility criteria as agreed to by both leagues. A player is only eligible to participate if they satisfy **all finals eligibility requirements of both the originating league and the host league**. This includes (but is not limited to) the minimum number of matches played, registration deadlines and financial status of the player and club. The host league reserves the right to refuse a permit where eligibility or competition integrity concerns exist
- 10) Any breach of finals eligibility requirements will result in penalties applied under the host league's by-laws, including but not limited to match forfeiture and player sanctions
- 11) All appearances must be recorded in PlayHQ and accessible to both leagues
- 12) Players who are reported for an on-field offence shall have the charge heard by the Independent Tribunal of the League within which the offence occurred, and both leagues shall apply the penalty.
- 13) This agreement **cannot** be altered unless agreed to by both Leagues.



- 14) Players **cannot** play more than **one (1)** game per **day**. Players **cannot** play more than **two (2)** matches per weekend.
- 15) Players are covered under the host league insurance during matches
- 16) Either league may terminate this agreement by notifying the other league and AFL Victoria.
